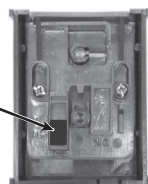

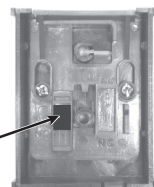


Position magnet here for N.C.
